Dr. Peter Loar Lore Part 2

Preface to Peter Loar Article:

For many years, the students of SHS have been beneficiaries of scholarships from the Estate of Dr. Peter and Marie Loar. Originally, the funds were set up as a loan fund through First National Bank of Oregon to be paid back by the student.

Since 1997, the fund, with Wells Fargo as the Trustee and SHSAA selecting the recipients, has provided scholarships that did not have to be paid back. Several months ago, Wells Fargo decided to terminate the trust and transfer the funds to SHSAA thus removing Wells Fargo from the process. As of the date of this newsletter, the termination is in process and documents for the transfer awaiting signatures from the high school business manager.

Fred Parkinson, Jr. has done some extensive research on the life

of Dr. Loar. This is part 2 of the article on the history of the early Silverton Doctor and his contributions to the Silverton community.

Dr. Loar's remarkably long service to his community was perhaps more visible than his hunting, fishing and bee-keeping activities. His involvement in city affairs began in 1911 when he was appointed Silverton's Health Officer, a post he would hold for 38 years, according to several sources. Whenever a health-related issue arose in Silverton, Dr. Loar would be the city official to disseminate appropriate information to the public.

In no small part, many of Dr. Loar's civic accomplishments, especially during the depression years of the late 1930s, came about through his long association with the Silverton Planning Council and then the subsequent Silverton Planning Commission. Originally sponsored by the Lutheran Brotherhood in the late 1920s to foster youth development, the Planning Council eventually evolved into a non-governmental civic organization with representatives from virtually every church, fraternal and civic organization in town. It was tasked with making "the community a happier, healthier and more desirable place

to live by inaugurating far-reaching movements for civic betterment," according to a profile appearing in a 1938 Silverton Appeal-Tribune article. The council was eventually replaced in 1942 by the creation of the Silverton Planning Commission.

One of Dr. Loar's early projects was his support for improving roads. As the use of automobiles exploded in the early twentieth century, the national "Good Roads Movement" inspired the creation of the Cascade Highway Association in 1928 with Loar as its first President. It initially promoted increased commerce to east Willamette Valley communities by upgrading, to State Highway status, a highway starting from Oregon City to the Eugene area. This road followed the general route of the old Territorial Road which today loosely follows that of Oregon Highway 213. The organization would also push for connecting all the various sections of the new Silverton-Salem Highway from Salem through Central Howell to Silverton in the 1940s.

For many years he also chaired the Roads Committee of the local Chamber of Commerce which

Darlene Fogarty Beyerle

Darlene received her Bachelors of Science and Masters of Education from Oregon State University with honors and her Leadership and Administration degrees from Portland State University. She taught as a business educator at North Salem High School, Tillamook High School, and South Salem High School before joining Silverton Union High School.

Darlene worked for 31 years in Silverton. Initially she was a business education teacher and FBLA advisor and was involved in student activities at the local and state level for 15 years. She supervised the Business, Industrial Arts, and Fine Arts Departments where she coordinated curriculums, budgets and supervision of staff in the elective programs. In 1990 Darlene joined the Guidance counselor department where she supervised college planning and scholarship programs, department budget preparation and presentation, hiring and coordinating professional development of staff, as well as overseeing the Teen Parent, Natural Helpers and START programs. In 1993 she became Assistant Principal with responsibilities for curriculum development, supervising and hiring staff, and coordinating the Evening school

and PASS programs. A unique opportunity and major responsibility at that time was coordinating the design and development of Phase One of the new high school campus with the architect and staff over a period of 3 years. She was the Assistant Principal in the new building and then assumed the role of Principal of the split campuses until retiring.

Darlene's commitment to education and the district after retiring included working with the district as a special projects advisor at the administrative level. She worked with the ESD on Crisis Team Responses, as a School and Colleges Accreditation Team Evaluator, on area School Safety Evaluation teams and as a member of the Chemeketa Office Advisory Committee and Regional Educational Reform Presenter.

In retirement she enjoys reading and outside activities including gardening, hiking, and traveling.

Eileen N Williams

Eileen graduated from Maui High School, Kahului, Hawaii in 1962 and received her Bachelors in Education, Oregon College of Education (OCE), Monmouth, Oregon in 1966.

While working for the Teaching Research Division at OCE (1968-1970) she researched the interactions of “colors and music” with preschoolers. Her research was instrumental in the creation of “Sesame Street” TV program.

Eileen was an Elementary school teacher for 32 years in the Silver Falls School District.

After retirement in 2001, she returned to teaching as the District’s Math Teacher on Special Assignment and as an elementary education Math Intervention Teacher. She remains active in education as a tutor/mentor for the After School Activity Program serving 6, 7, & 8th grade students.

She served as a Director for the Silverton High School Scholarship Fund (SHSSF) from 1997 to 2008 when that Fund merged with the SHS Alumni Association (SHSAA).

She continues her valuable service to the Silverton High School community by assisting in the annual evaluation and selection of many alumni scholarships.

As an SHSSF Director and an SHSAA Scholarship Evaluator she has been a key participant in the awarding of over 1,600 scholarships totaling more than \$1,200,000 during the last 20 plus years.

dealt with improving the quality of Silverton's network of streets.

As a physician, Dr. Loar was naturally interested in improving Silverton's medical facilities. In 1918, he helped fashion bylaws for the newly created Silverton Hospital Association that issued stock, leading to the establishment of the North Water Street Hospital. In a relatively short time, it became apparent that the new hospital's facilities, located in a converted private home, would not meet the needs of the community for long. As early as 1931, Dr. Loar encouraged the City of Silverton to take over the hospital so bonds could be issued for the construction of a modern municipal hospital. This never occurred, but several years later the need for additional hospital facilities became so critical that a building addition to the existing North Water Street hospital was in the planning stage. These plans were put on hold with the passing of Rebecca Stevens Mount, who had built a house on Phelps Street with her husband, H. D. Mount. She left the property to her son, Guy, who happened to be an Oregon City physician. Guy realized the serious need for a new hospital in Silverton and that his property would be a perfect site for a new facility, so he sold the property to the hospital association. Construction of the new hospital was begun in 1936 with seed money for the project provided by an earlier bequest to the Hospital Association by a local hop grower. The hospital opened to the public on April 11, 1937.

The late 1930s saw a flurry of civic activity by the Silverton Planning Council, led by Dr. Loar. It was involved with many simultaneous community projects, including

constructing a sewage treatment and disposal plant, building the municipal swimming pool and the construction of the new Schlador Street high school building, among others.

In addition to the Silverton Planning Council, two important partners in Silverton's ongoing development were the Works Progress Administration and the Public Works Administration, both set up by the Federal Government to build up public infrastructure. Many of Dr. Loar's projects involved the WPA or PWA providing 45% of the cost of a project, with the City or school district supplying 55%.

At a busy meeting in July 1938 the Planning Council, led by Dr. Loar and T.T. Leonard, voted to ask School District 4 to hold a bond election to build a new senior high school. In 1938, the need for more adequate high school space was again apparent, inspired by student overcrowding, as well as by new state-wide standards relating to mandated physical education facilities. A bond election was successful and, with help from the PWA, the new Schlador Street campus opened for the 1939-1940 school year.

At that same July meeting, the Council, along with Dr. Loar, in his capacity as Silverton's health officer, asked the City to vote on a new sewage treatment plant. Silverton's substandard sewage situation had been studied for years. Much of Silverton's sewage was being dumped into Silver Creek downstream from town, in the Brush Creek District, angering neighbors. A successful bond election was held in September 1938 to authorize construction of a new plant. As with the new high school building, the PWA participated in the project with the customary 45% /55% split in financing. The new plant opened in June 1939.

Many people may not know this, but the Silverton swimming pool used to be located in Silver Creek adjacent to the city park near where the footbridge is located today.

Because the water in the pool could no longer be treated to comply with hygienic standards, Dr. Loar, as the City Health Officer and a member of the Silverton Planning Council proposed applying for a WPA grant to help defray the cost of building a municipal swimming pool on land recently donated to the city across from the park. City voters approved the plan, the grant was approved and the new municipal swimming pool opened in May 1940. A short time later the first foot bridge was built from the pool site to the park with lumber donated by Dr. Loar.

Perhaps the most enduring of all Dr. Loar's projects was his desire to change the configuration of Silverton's city government. The February 2, 1939 Silverton Appeal-Tribune reported that "the Community Planning Council has turned its attention to a study of the various types of city government." A committee was formed to investigate the Council-Manager form of city government including plans to visit Oregon City to learn about their municipal system.

The current city government consisted of a mayor and city council, plus a separate, autonomous, Water Commission responsible for collecting revenue and maintaining Silverton's water system. The proposed change involved establishing a new city charter that would mandate hiring a professional city manager with municipal training and expertise to administer all city functions, thus consolidating overall responsibility in one individual. The City Council would be elected by the public and would be responsible for determining city policies. The coun-

cil would select the mayor from among its members. The council would then hire the city manager, based on qualifications, who would be responsible for administering policies enacted by the council.

Over the next several months, Dr. Loar spoke to many organizations, including the city council, as he promoted the new plan. He stressed that the Council-Manager system would be more efficient and would make city government less susceptible to political influences.

The January 10, 1940 Silverton Appeal-Tribune reported, in summarizing Dr. Loar's comments in support of the change: "The present City Charter limits the city council to certain things that the people have voted, whereas the proposed Planning Council charter empowers the city council to do anything not prohibited by acts of the state legislature."

The proposed change was not without controversy. It generated much discussion, both for and against the plan, making it one of the most hotly debated city issues in many years.

By early 1940, Dr. Loar was impatient that the committee the city council had set up several months ago to investigate the issue hadn't yet filed their report. At the January 16, 1940 Planning Council meeting Dr. Loar announced that initiative petitions would soon be circulated to get the issue on the May 1940 primary ballot. As it turned out, the deadline for submitting initiative petitions had just passed so any petitions submitted would be non-binding and would be used only as a tool to influence the city council. A city ordinance was discovered a few weeks later that permitted petitions to be circulated that would allow the issue to be put on the May 1940 primary ballot.

The issue made the ballot and passed by a five to three vote ratio at the May 17, 1940 primary election, but that wasn't necessarily the end of the matter. Several citizens complained that the non-partisan measure had only appeared on each political party's ballots, with no non-partisan ballots available, thus preventing people with no political party affiliation from voting on the charter change.

Considering the legality of the election might be in doubt, members of the Water Commission were hesitant to turn over its assets to the city, fearing personal liability in the event the election was ruled invalid. In August 1940 the Water Commission filed suit against the City to resolve the issue.

In the meantime, the municipal government adopted the new system and the Water Commission was abolished. An interim City Manager was selected to serve until the outcome of the civil suit was determined. After hearing the case in January, at which time Dr. Loar testified, the lawsuit was ultimately dismissed by the judge in May 1941, paving the way for E. K. Burton to be hired as Silverton's first City Manager.

The City Council continued to select the mayor from among its members until 1976 when the charter was amended by a citizen vote to allow for the popular election of mayor.

By all accounts, Dr. Loar was a person who wanted to get things done and could be downright impatient when things didn't come about as quickly as he would have liked.

Dr. Loar was involved in civic affairs soon after arriving in Silverton in 1910. Some of his lesser known activities included contributing to the Silver Falls Timber Company subscription drive in 1916. He also

served on the 1920 Chautauqua advertising committee. A long-time member of the Chamber of Commerce, he was Vice-President in 1933 and a charter member of the Silverton Rotary club in 1936. In 1941, he supported converting the old Fischer Mill property into a community center.

Dr. Loar retired from his medical practice in 1949, but that didn't stop his civic involvement. He continued to serve on the Planning Commission for several years. He passed away in 1959.

Dr. Peter A. Loar's abundant civic projects spanned several decades. Examining his various community interests, it becomes apparent that virtually all of his projects involved contributing to citizen safety, as well as promoting civic efficiency. If there had been a Silverton First Citizen in Dr. Loar's time, there's no doubt that he would have been awarded that honor at some point.

Temp Away

We mail our Alumni Newsletter twice a year, on the third Tuesday of May and November. Please add the SHSAA to your change of address list.

If you're a "snowbird" and move at either of those times, please let us know of your temporary address. We can change your address for just that one mailing. The newsletters are sent BULK MAIL and the post office does not forward those, even if you've given them a forwarding address. They are tossed and/or returned to us. We also have to pay sixty-two cents (62¢) to be notified of your "Temp Away" status.

Quite often I receive an Email asking why a person did not receive a newsletter. We keep a copy of the labels so we can tell if that person was actually on the mailing list. Many times the answer is yes, the newsletter was mailed, and yes to the address we have on file. However, when looking over the returned newsletters, there's that person's newsletter with "Temp Away" stamped on it by the post office.

If that person is a paid member, we will send out another newsletter. Usually that's about \$1.50 for First Class, which is the way a second one would have to be sent.

We get a great discount when all the newsletters are sent via bulk mail. But you add 62¢ for the notice that they were temporarily away and another \$1.50 to send a second copy, and our costs really go up. Keep in mind this additional expense takes away from our bank balance, and in turn can reduce the amount we have available for scholarships.

So please, if you intend to change your address in May or November, let us know ahead of time. We can put in a temporary address for the one mailing, and immediately change it back to your "normal" address for the next issue.

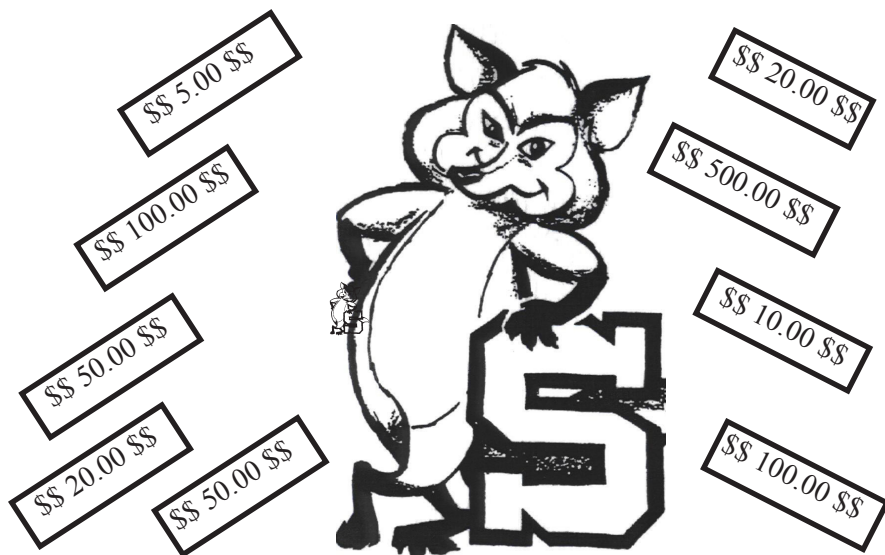
